**JUSTICE FUND EMERGENCY RELIEF**

Supports immediate response to and relief from disasters that occur in SPF's 12 regional focus states. Funding is available for a specific event on an "as needed" rolling basis. While priority will be given to organizations that have a component of community organizing in their missions, SPF recognizes that many organizations are called upon to facilitate emergency response in crisis situations.

**JUSTICE FUND RENEWAL**

Supports mid-term and long-term rebuilding efforts following disasters affecting communities in SPF's 12-state Southeastern region. Funding in this category is reviewed and awarded quarterly, though exceptions apply for COVID funding requests which are reviewed on a rolling basis. Organizations that apply for funding from the Renewal Program have community organizing components consistent with the mission of Southern Partners Fund.
